#### ARTICLES OF ORGANIZATION

OF

#### JCG PROPERTIES, LLC

#### <u>ARTICLE I</u>

#### **NAME**

The name of this limited liability company (the "Company") shall be **JCG PROPERTIES**, **LLC** and its mailing address is 1568 Crossbeam Drive, Casselberry, FL 32707, and its principal place of business is 1568 Crossbeam Drive, Casselberry, FL 32707.

#### ARTICLE II

The headings or captions of these various articles of organization are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various articles shall not be influenced by any of said headings or captions.
