ARTICLES OF ORGANIZATION

OF

NORRIS, L.L.C.

THE UNDERSIGNED certify they intend to form a limited liability company under the laws of the State of Florida and hereby declare that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

ARTICLE I NAME

The name of the limited liability company (the "Company") shall be **NORRIS L.L.C.**

ARTICLE II ADDRESS

**ARTICLE IV
DURATION**

The duration for the Company shall be perpetual.

**ARTICLE V
REGISTERED AGENT AND OFFICE**

**ARTICLE VI
MANAGEMENT**

**ARTICLE VII
ADMISSION OF NEW MEMBERS**

The existing member of the Company shall have the right to admit additional members to the Limited Liability Company, by the affirmative vote or consent of members holding two-thirds of the members' percentage in interest, in accordance with the terms and conditions of the Operating Agreement of the Limited Liability Company.

**ARTICLE VIII
CONTINUATION OF BUSINESS OPERATIONS**

The remaining members of the Limited Liability Company, by the affirmative vote or consent of members holding two-thirds of the members' percentage interest (other than the member who caused the withdrawal event) may continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company.

**ARTICLE IX
TRANSFERABILITY OF MEMBER'S INTEREST**

A member's interest in the Company shall not be transferred unless the transfer is approved by the members in accordance with the Company's Regulations.

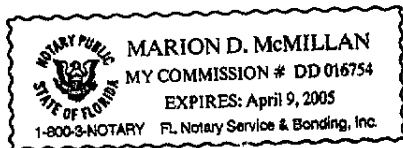
