

**ARTICLES OF ORGANIZATION
OF
GLENN JENKINS GENERAL CONTRACTOR, LLC**

I, the undersigned person, do hereby adopt the following Articles of Organization for the purpose of forming a Florida Limited Liability Company, with an effective date of February 25, 2002.

ARTICLE I:

Name & Address: The name of the Company shall be GLENN JENKINS GENERAL CONTRACTOR, LLC. The principal place of business/ mailing address is 6614 Ilex Circle, Naples, Florida 34109.

ARTICLE II:

Duration. The company shall continue for a term of twenty-five (25) years. At the end of said term, the Company shall wind up its affairs unless (1) the term set forth above is extended by mutual agreement of all Members and (2) the Articles of Organization are amended to reflect the extended term of the Company as required by Florida law. However, the Company under Florida law shall be dissolved upon the occurrence of either of the following events:

- (1) by written agreement signed by the members entitled to receive a majority of the profits of the limited liability company, unless otherwise provided in the operating agreement;
- (2) upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of the member or upon the occurrence of any other event that terminates the continued eligibility for membership of a member in the limited liability company, unless the business of the limited liability company is continued by the members.

ARTICLE III:

Business Purpose. The Company may conduct or promote any lawful business, or purpose other than banking or insurance, for which a partnership, General Corporation, or Professional Corporation may conduct or promote.

ARTICLE IV:

Registered Agent. The Company shall continuously maintain an agent in the state of Florida for service of process who is an individual residing in said state. The street address of the initial registered office in the state shall be 6614 Ilex Circle, Naples, Florida 34109 and the name and street address of the registered agent shall be Glenn Jenkins, 6614 Ilex Circle, Naples, Florida 34109.

ARTICLE VI:

Management. The Company shall is to be managed by Glenn Jenkins, 6614 Ilex Circle, Naples, Florida 34109, shall hold office until he resigns or is removed. The Company shall be managed pursuant to the terms of the Operating Agreement, or any amendments thereto.

ARTICLE VII:

Records. The company shall keep at its principal place of business all records required to be maintained by the Company pursuant to the State of Florida, which records include, but are not limited to, the following:

- 1.1 A current list in alphabetical order of the names and first known business street addresses of each Member.
- 1.2 A copy of the stamped Articles of Organization and all certificates of amendment thereto.
- 1.3 Copies of all tax returns and financial statements of the Company for the past three years.

ARTICLE VIII:

Contributions. No Member shall be obligated to make any contribution to the Company except those specifically set forth in the Operating Agreement adopted by the Members of the Company.

ARTICLE IX:

Dissolution. This Company shall be dissolved with the written consent of all its Members.

ARTICLE X:

Annual Report. The Company shall file all annual reports required by Florida Law during the month of its anniversary date of formation as required by the State of Florida.

ARTICLE XI:

Amendments. The Articles of Organization shall be amended from time to time as required by the State of Florida.


ARTICLE XII:

ARTICLE XIII:

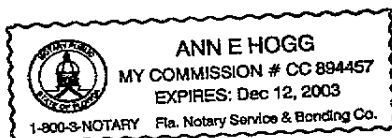
