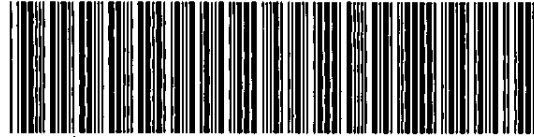

RESIGNATION OF REGISTERED AGENT


