Company shall have all the rights and obligations of a member under the "Limited Liability Company Agreement."

**ARTICLE X -- CONTINUATION OF BUSINESS**

In the event of the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of an event which terminates the continued membership of a member in the Company, the remaining members of the Company shall have members based on their relative contributions as set forth in ARTICLE VII hereof, agree to continue the business of the Company. The remaining members must agree within ninety (90) days from the date of such event whether to continue the business of the Company.

In the event the remaining members fail to continue the business of the Company within such ninety (90) day period, the Company shall be dissolved and liquidated.
