Article 1. Name

The name of the Limited Liability Company is Pirates & Poets, LLC.

Article 2. Duration

The duration of the Limited Liability Company is perpetual.

Article 3. Principal Office and Mailing Address

The principal place of business and the mailing address of the Limited Liability Company are
12693 East Tamiami Trail, Naples, Florida 34113.

Article 4. Initial Registered Office and Agent

The initial registered office of the Limited Liability Company is 12693 East Tamiami Trail,
Naples, Florida 34113. The name of the initial registered agent at that address is Tara LaGrand.

Article 5. Admission of New Members

The Limited Liability Company may admit additional members upon a vote of all members in

with the Florida Department of State.

Article 8. Commencement of Existence

The Limited Liability Company's existence shall commence upon the filing of these Articles of Organization with the Florida Secretary of State.

Article 9. Regulations

These Articles of Organization and the Florida Limited Liability Company Act shall be deemed to be the regulations of the Limited Liability Company unless and until the members have otherwise adopted additional or inconsistent provisions in connection with any matter permitted to be addressed in the regulations.

Article 10. Amendment

The Limited Liability Company reserves the right to amend or repeal any provisions contained in these Articles of Organization or any amendment to them, and any right conferred upon the members are subject to this reservation.

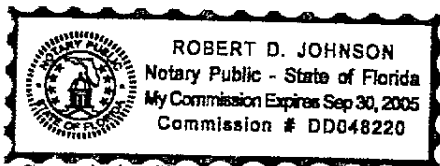


