

ARTICLES OF ORGANIZATION

ROTABLE, LLC

A LIMITED LIABILITY COMPANY


(Pursuant to s. 607.407, Florida Statutes)

1. Name. The name of the limited liability company is ROTABLE, LLC.
2. Purpose. The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.
3. Address of Principle Office and Mailing Address. The address of the office of the limited liability company is: 2800 Sommerset Drive, Unit J-202, Ft. Lauderdale, Florida 33311.
4. Term. Term of this LLC shall be perpetual.
5. Members at Time of Formation. There will be at least one member at the time the limited liability company is formed.


