2. The foregoing Amendment was adopted by the sole organizer of this limited liability company on the 18<sup>th</sup> day of April, 2002.

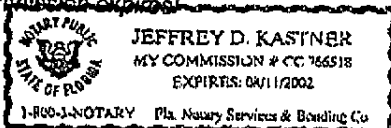
