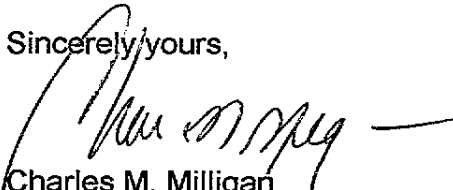

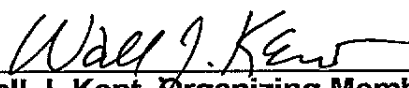
1. The name of the limited liability company is **Kent Bluewater, L.L.C.**

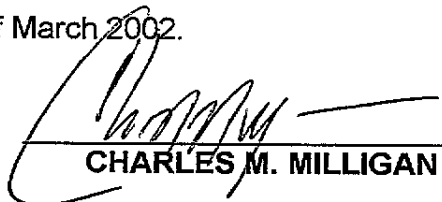
