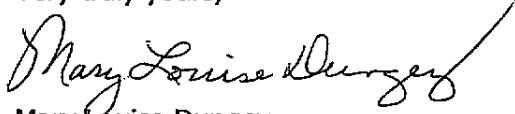

**ARTICLES OF ORGANIZATION OF
SMEEVE & SMASH INVESTMENTS, LLC**

A LIMITED LIABILITY COMPANY

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I
NAME**

The name of the limited liability company shall be Smeeve & Smash Investments, LLC (the "Company").

**ARTICLE II
PURPOSES AND POWERS**

This Company is organized to engage in any activity or business in which a limited liability company may engage under the laws of the United States and of the State of Florida.

**ARTICLE III
DURATION**

**ARTICLE IV

**ARTICLE VIII
RESTRICTIONS ON MEMBERSHIP**

New Members may only be admitted by the unanimous vote of the Members, unless otherwise specified in Regulations adopted by all of the Members. The terms and conditions of the admission of a new Member, including contributions required of new Members shall be determined by the unanimous vote of the Members as of the time of admission of such new Members to the Company unless otherwise specified in Regulations adopted by all of the Members.

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, or the occurrence of any other event that terminates the continued membership of a Member in the Company, the remaining Members shall have the right to continue the business upon the unanimous written consent of such remaining Members.
