ARTICLES OF ORGANIZATION OF MEDICAL RECOVERY SERVICES, L.L.C.

2002 MAR 18 ED DIVISION OF CORPORA

The undersigned, acting as the organizer and authorized representative for the purpose of formation of a Limited Liability Company under the Florida Limited Liability Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I. NAME

The name of this Limited Liability Company shall be MEDICAL RECOVERY SERVICES, L.L.C.

ARTICLE II. PLACE OF BUSINESS AND REGISTERED AGENT

The registered office and principal place of business of this Company shall be 603 Indian Rocks Road, Belleair, Florida 33756, and such other place or places as the members from time to time may determine. The street address and mailing address are the same.

ARTICLE III. PURPOSE

The Company is created and organized for the purpose of owning and operating a consumer collection agency which specializes in collecting debts owed to physicians and medical service providers and to transact any lawful business, profession or activity for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all of the powers granted to a Limited Liability Company under the laws of the State of Florida.

ARTICLE IV. MANAGEMENT
