**AMENDMENT TO THE
ARTICLES OF ORGANIZATION OF

The undersigned Authorized Representative does hereby execute, acknowledge and file the following Amendment to the Articles of Organization of AVIGNON 5, LLC.

1. The name of the Corporation is currently AVIGNON 5, LLC.
2. The date of the filing of the Articles of Organization was March 22, 2002.

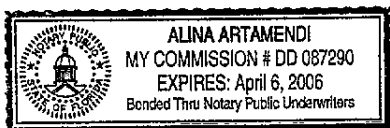
