ALANAS COROLLA The undersigned, being a member or duly authorized representative of a member, desiring to form a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes does hereby adopt the following Articles of Organization:

ARTICLE I - NAME:

The name of the limited liability company is Bryceville Timber, LLC (the "Company")

ARTICLE II - Address:
