## **ARTICLES OF ORGANIZATION**

### **Article I – NAME**

The name of this limited liability company shall be The Circle of Champions LLC.

### **Article II – Address**

The mailing address and street address of the principal office of this limited liability company 4054 Rex Drive, Winter Garden, Florida 34787.

### **Article III – Duration**

This limited liability company shall commence its existence March 18, 2002. This company's duration shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

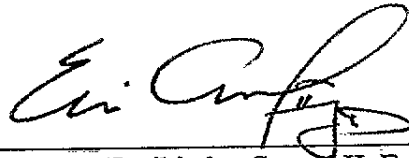
# CERTIFICATE OF DESIGNATION OF REGISTERED AGENT/REGISTERED OFFICE
