#### ARTICLES OF ORGANIZATION

#### **OF**

### LYONS TECH IV, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes (1995) Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

# ARTICLE I

#### <u>NAME</u>

The name of the limited liability company shall be LYONS TECH IV, LLC (the "Company"). The principal place of business and mailing address of the Company in Florida shall be 1096 East Newport Center Drive, Suite 100, Deerfield Beach, FL 33442.

## **ARTICLE II**

## **DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company's earlier dissolved in accordance with the laws of the State of Florida.
