ARTICLES OF ORGANIZATION OF Collier Beach Investments, LLC, A LIMITED LIABILITY COMPANY

The undersigned authorized representative of a member of this company declares that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE I NAME AND PRINCIPAL OFFICE

The name of the limited liability company shall be **Collier Beach Investments, LLC**, its mailing and street address is 8171 Bay Colony Drive, Naples, Florida, 34108, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE III PURPOSES AND POWERS
