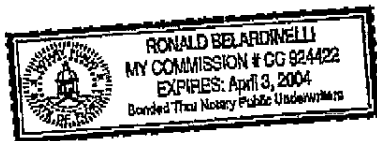
Article 5. Commencement of Existence


The Limited Liability Company's existence shall begin at the date and time when these Articles of Organization are filed with the Florida Department of State.


