ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF
SUMMERLIN PROPERTIES, LLC

The undersigned, being a Manager of the above-named company, hereby certifies that the following amendment to the Articles of Organization was duly adopted unanimously by all of the members of the company by written resolution dated April 10, 2002.

Article IV is hereby amended to read as follows:

The Company shall be a manager-managed company. The Operating Agreement may contain any provision for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
