INITIAL REGISTERED OFFICE AND INITIAL REGISTERED AGENT



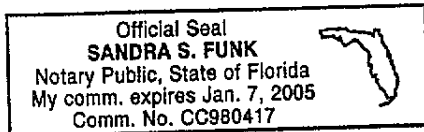
