**ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION OF
SOUTHSIDE INVESTMENTS, L.L.C.**

The undersigned does hereby execute, acknowledge and file the following Amendment to the Articles of Organization of SOUTHSIDE INVESTMENTS, L.L.C.

1. The name of the Corporation is currently SOUTHSIDE INVESTMENTS, L.L.C.
2. The date of the filing of the Articles of Organization was March 28, 2002.
3. The Articles of Organization are amended as follows:

a. By deleting all of Article I hereof, and by substituting in lieu thereof, all the following:

ARTICLE I
NAME

The name of the limited liability company shall be "SOUTHSIDE INVESTMENTS DIXIE HIGHWAY, L.L.C." (the "Company").

b. By deleting all of Article II hereof, and by substituting in lieu thereof, all of the following:

ARTICLE II
PRINCIPAL PLACE OF BUSINESS

c. In all other respects, the Articles of Organization shall remain unchanged.

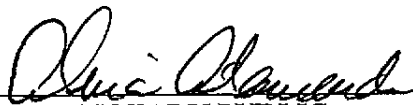
