**ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION OF

The undersigned does hereby execute, acknowledge and file the following Articles of Amendment to the Articles of Organization of SOUTHSIDE LICENSE, L.L.C.

1. The name of the Company is currently SOUTHSIDE LICENSE, L.L.C.
2. The date of the filing of the Articles of Organization was March 28, 2002.
3. The Articles of Organization are amended as follows:
 - a. By deleting all of Article I hereof, and by substituting in lieu thereof, all of

the following:

**ARTICLE I
