**ARTICLES OF ORGANIZATION  
for  
VILLAGE SQUARE I, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

**Article I - NAME**

The name of the limited liability company shall be Village Square I, LLC ("Company").

**Article II - ADDRESS**

The mailing address and street address of the principal office of the Company shall be 2806 First Street, South, Jacksonville Beach, Florida 32250.

**Article III - DURATION**

The Company is to exist as specified in the Operating Agreement.

**Article IV - PURPOSES AND POWERS**

The business and purposes of the Company are to acquire, own, hold, lease, mortgage, option, sell, convey, transfer and otherwise dispose of real property as specified in the Operating Agreement, and to engage in any other lawful act or activity which may be carried on by a limited liability company under the Florida Limited Liability Company Act which the members may from time to time authorize or approve pursuant to the provisions of the Operating Agreement.

**Article V - MANAGEMENT**

The Company shall be managed by one (1) or more managers and is, therefore, a manager-managed company.

**Article VI - INITIAL REGISTERED OFFICE AND AGENT**

**Article VII - INDEMNIFICATION**

The company shall indemnify its members, managers, officers, employees, and agents to the full extent permitted by law.

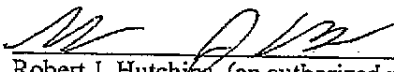

The existence of the Company shall commence on March 27, 2002.



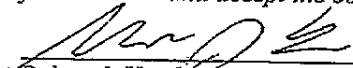
