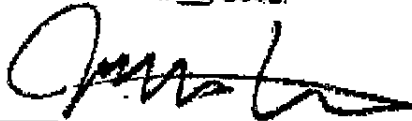
**ARTICLE VIII - Members Rights to Continue Business:**
