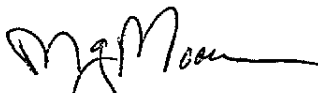

**ARTICLES OF ORGANIZATION
OF
RIDGEPORT RESTAURANT DEVELOPMENT GROUP, L.L.C.**

The undersigned, pursuant to §608.407, Florida Statutes, adopt the following Articles of Organization for such limited liability company.

ARTICLE I – Name

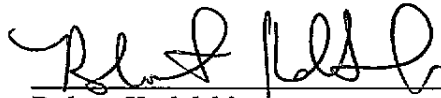
