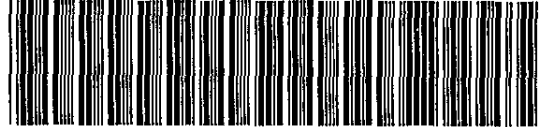



WALLACE INVESTMENT GROUP, LLC


