**ARTICLES OF ORGANIZATION**

The undersigned, being a duly authorized representative of a member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization.

**ARTICLE I: NAME**

The name of the limited liability company is AAA PRECISION COOL, LLC (the "Company")

**ARTICLE II: ADDRESS**

The principal office and mailing address of the Company is: 896 N. Federal Highway, PMB 712, Pompano Beach, Florida 33062-4316.

**ARTICLE III: DURATION AND CONTINUATION**

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of the State, and shall continue perpetually, unless terminated (i) in accordance with the Company's Regulations, (ii) by the unanimous written agreement of all Members, (iii) by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member, or (iv) upon the occurrence of any other event which terminates the continued membership of a Member. However, upon any such termination event, the existence and business of the Company may be continued with the consent of a majority of the remaining Members of the Company, or by amendment of these Articles of Organization providing for the continued existence of the Company.

**ARTICLE IV: PURPOSE**

The Company is organized to engage in any activity or business permitted under the laws of the United States and Florida.

**ARTICLE V: REGISTERED AGENT AND OFFICE**

The Company designates 896 N. Federal Highway, PMB 712, Pompano Beach, Florida 33062-4316 as the street address of the initial office of the Company and names Joe Bell the company's initial registered agent at that address to accept service of process within this state.

**ARTICLE VI: ADDITIONAL NAMES**

Additional Members may be admitted upon the approval of a majority of the Members of this Company, upon the written application of such new Member, in the manner set forth in the Regulations of the Company.

#### ARTICLE VII: MANAGEMENT

The company shall be conducted, carried on, and managed by no less than one (1) Manager, who shall be elected annually by the Members of this Company in the manner prescribed by and provided in the Regulations of the Company. Such Manager shall also have the rights and responsibilities described in the Regulations of the Company. The name and address of the initial Manager is as follows:

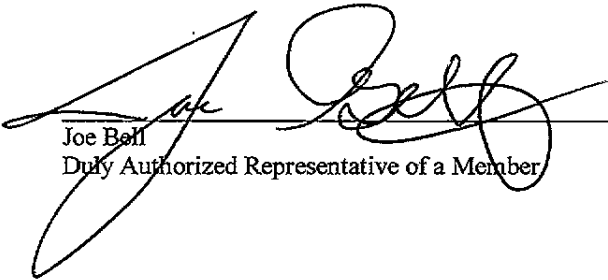

#### ARTICLE VIII: REGULATIONS
