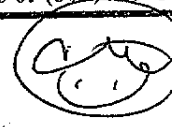


**ARTICLE III


