ARTICLES OF ORGANIZATION
OF
CANDANSK, LLC

The undersigned, desiring to form a limited liability company under the provisions of Florida Statute 608, as amended, hereby sets forth the following:

ARTICLE I
Name

The name of the Limited Liability Company is **CANDANSK, LLC**. (hereinafter referred to as the "Limited Liability Company")

ARTICLE II
Principal Office & Mailing Address

The principal place of business and mailing address of this Limited Liability Company shall be 10501 Roosevelt Boulevard North, St. Petersburg, FL 33716.

The initial members of this Company shall be set forth in the operating agreement adopted by the members. The admission of additional members shall be as stated in the operating agreement.



Written Operating Agreement



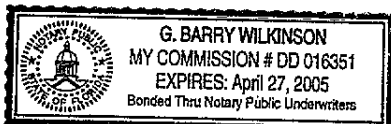


