Limited Liability Company Act, F.S. Chapter 608, hereby makes and files the following Articles & Organization.

ARTICLE I **NAME**

The name of the limited liability company is CIKCAKS, L.L.C. (the "Company").

ARTICLE II DURATION

EFFECTIVE DATE

The period of the Company's duration shall commence on March 27, 2002 and shall be perpetual, unless the Company is dissolved as provided for by law, by these Articles of Organization or in the Regulations ("Regulations") of the Company.

ARTICLE III MAILING AND STREET ADDRESSES
