The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be **6525 MPR, L. L. C.** ("Company").

ARTICLE II - MAILING ADDRESS

The mailing address and the street address of the principal office shall be 7535 Midnight Pass Road, Sarasota, Florida 34242.

ARTICLE III - REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the State of Florida is **GAY H. BOYLSTON**, 7535 Midnight Pass Road, Sarasota, Florida 34242.

ARTICLE IV - MANAGEMENT

The Company shall be a manager-managed company. The original manager shall be **GAY H. BOYLSTON** who shall serve under the terms as set forth in the Company's Operating Agreement.

ARTICLE V - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual.

ARTICLE VI - ORGANIZER

The member of the Company is **GAY H. BOYLSTON**, a natural person at least eighteen (18) years old.

ARTICLE VII - PURPOSES AND POWERS

The Company is organized for the purpose of owning real property and managing the same, and to transact any lawful business for which a limited liability company may be organized

under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE VIII - ADMISSION OF NEW MEMBERS

The Company may admit new members as provided in the Company's Operating Agreement.

ARTICLE IX - RELATIONSHIP OF ARTICLES OF ORGANIZATION TO OPERATING AGREEMENT

If a provision of these Articles of Organization differs from a provision of the Company's Operating Agreement, then to the extent allowed by law, the Operating Agreement will govern.

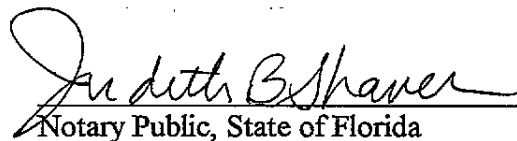

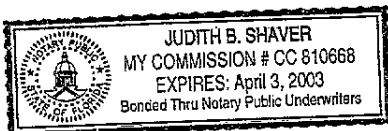
