ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is SJCK HOLDINGS, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The existence of the Company shall be effective as of April 1, 2002, and shall thereafter be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Principal Office. The mailing and street address of the Company's principal office is 4044 Roberts Point Road, Sarasota, Florida 34242.


