**INDEMNIFICATION**

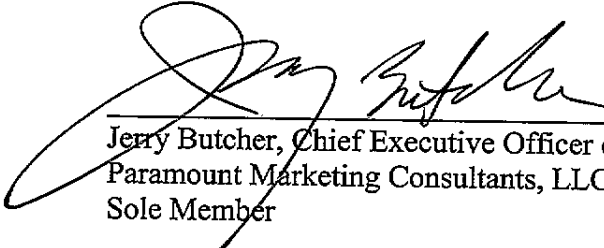
