# ARTICLES OF ORGANIZATION

# OF

# HANUKA BROS. REALTY L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### <u>ARTICLE 1 - NAME</u>

The name of the limited liability company shall be **HANUKA BROS. REALTY L.L.C.**, ("Company").

### **ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 126 Pheh Circle, Naples, Florida 34113 and the mailing address shall be the same.

The Company shall indemnify managers and officers of the Company who was wholly successful, on the merits or otherwise, in the defense of any proceeding to which the manager or officer was a party because the manager or officer is or was a manager or officer of the Company against reasonable attorney fees and expenses incurred by the manager or officer in connection with the proceeding. All references in these Articles of Organization to "manager", "officer", "employee" and "agent" shall include the heirs, estates, executors, administrators and personal representatives of such persons.
