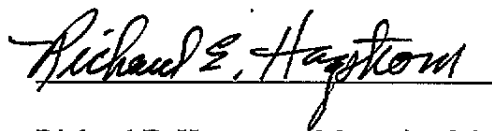
## ARTICLE 6

### ADMISSION OF ADDITIONAL MEMBERS

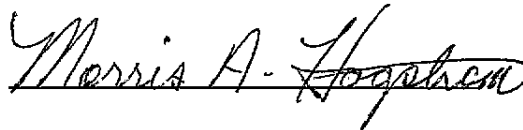
