ARTICLES OF ORGANIZATION OF REMEDY GOLF SCHOOL L.L.C.

ON AND FILED AND STATE OF STAT The undersigned, for the purpose of forming a limited liability company under the Fig. Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I NAME
