ARTICLES OF ORGANIZATION
OF

ARTICLE I. - NAME

The name of the limited liability company is pH BALANCED INVESTMENTS, LLC. The limited liability company is organized under the Florida limited liability company statutes.

ARTICLE IX. - SURVIVING MEMBERS RIGHTS

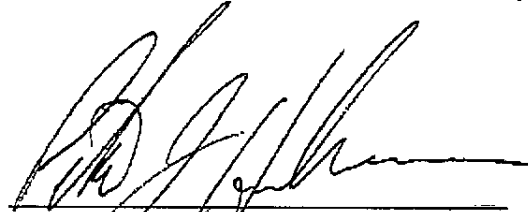

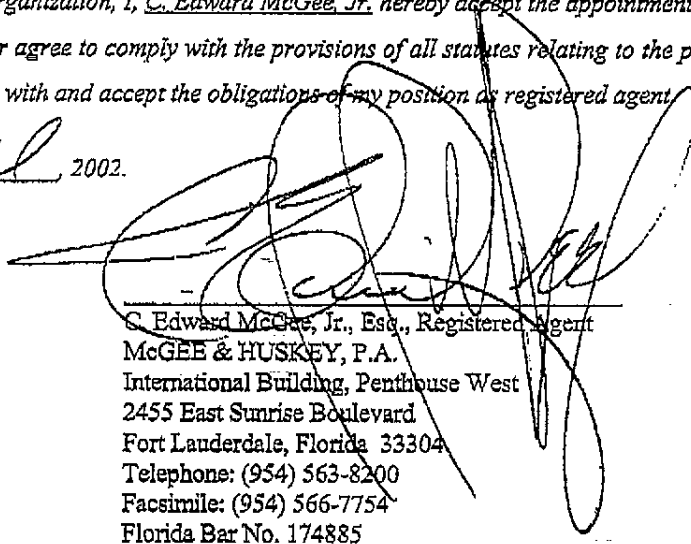
