Each member shall make additional capital contributions to the company only on the unanimous consent of all the members, or as otherwise provided in the regulations,

ARTICLE VII – ADMISSION OF NEW MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the company except upon the unanimous written consent of all the members of the company, and on such other terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company only as set forth in the regulations of the company, and the transferee shall have no right to participate in the management of the business and affairs of the company, or become a member of the company, unless all the members of the company – excluding the member proposing to dispose of his or her interest – approve of the proposed transfer by written consent.

ARTICLE VIII – MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy or dissolution of a member of the company, or on the occurrence of any other event that terminates the continued membership of a member of the company, unless the business of the company is continued by unanimous vote of all the remaining members of the company.

ARTICLE IX - MANAGEMENT

The company shall be managed by the members – all of whom shall have equal right in the management, conduct and regulation of the company's business - per the regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
