

ARTICLES OF ORGANIZATION

OF

JPL CONSULTANT SERVICES, LLC

A Florida For-Profit Limited Liability Company
A MANAGER-MANAGED COMPANY

Pursuant to the provision of Chapter 608.407, Florida Statutes, the undersigned Florida Limited Liability Company adopts the following articles of organization.

ARTICLE I

NAME

The name of the limited liability company shall be JPL CONSULTANT SERVICES, LLC, (the "limited liability company").

ARTICLE II

ADDRESS

The mailing address and street address of the principal office of the Limited Liability Company shall be 1021 N.W. 203rd Street, Miami, FL 33169.

ARTICLE III

DURATION

The duration of the limited liability company is perpetual.

ARTICLE IV

PURPOSE

The general purposes for which the limited liability company is organized are:

1. To provide business consulting services to residents and small businesses in Miami-Dade County, and the State of Florida.

2. To engage in any other trade or business which can, in the opinion of the members of the limited liability company, be advantageously carried on in connection with and/or auxiliary to the foregoing business.

ARTICLE V
MANAGEMENT


The Limited Liability Company is to be managed by one or more managers and is, therefore, a manager-managed company.

ARTICLE VI
