The effective date of these Articles shall be March 8, 2002 (date must be specific and cannot be more than five (5) business days before or 90 days after the date of filing).

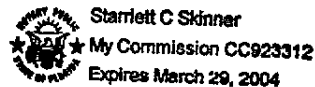
