ARTICLES OF ORGANIZATION

OF

OCEAN TRADING LC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, Thereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be OCEAN TRADING LC, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 3515 Northwest 114th Avenue, Miami, Florida 33178 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE

ARTICLE 7 - ADMISSION OF NEW MEMBERS

No additional member(s) shall be admitted to the Company except with the unanimous written consent of all the member(s) of the Company and upon such terms and conditions as shall be determined by all the member(s).
