(Pursuant to the provisions of Section 608.411 the Florida Limited Liability Company)

The undersigned, being a member and manager of **DOCTOR'S ORDERS, LLC**, a limited liability company organized and existing under the laws of the State of Florida (the "Company"), the Articles of Organization of which were initially filed with the Department of State of the State of Florida on April 11, 2002, DOES HEREBY CERTIFY THAT:

2. Article I of the Company's Articles of Organization is hereby amended and replaced in its entirety to read as follows:


"ARTICLE I - Name
