**ARTICLE 3 - EFFECTIVE DATE**

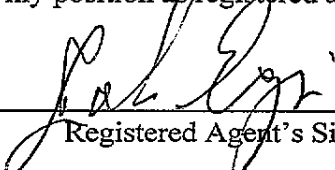
