

AMENDED & RESTATED ARTICLES OF ORGANIZATION
OF GUARANTY TRUST & TITLE, USA, L. L.C.

The undersigned, for the purpose of amending Articles of Organization of a limited liability of the Florida Limited Liability Company Act., hereby make, acknowledge, and company under the Florida Limited Liability Company Act., hereby make, acknowledge

ARTICLE 1 - NAME

The name of the Limited Liability company shall remain as GUARANTY TRUST & TITLE, USA, L.L.C.

ARTICLE II - ADDRESS

ARTICLE III - DURATION
