Name**

ARTICLE VII
Continuance of Business

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. In such event, the business may be continued only on the unanimous written consent of the remaining members.

Additional Provisions

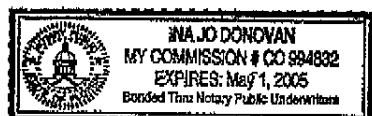
The power to adopt, alter, amend or repeal the regulations of the Company is vested entirely in the members.
