The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Act, do hereby adopt the following Articles of Organization.

**ARTICLE 1.0**

The name of the Limited Liability Company shall be "NAPA Auto Parts of Trenton, LLC".

The duration of the company is perpetual.

#### **ARTICLE 8.0 DISTRIBUTIONS**

The Company may make distributions to its Members and Managers upon the affirmative vote of a majority of the Managers. Unless otherwise unanimously agreed by the Members and Manager, all distributions to Members shall be made in accordance with the Members' interest in the Company.

#### **ARTICLE 9.0 SHARES OR INTERESTS**



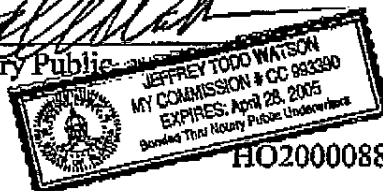


