ARTICLES OF ORGANIZATION

OF

(a Florida Professional Limited Liability Company)

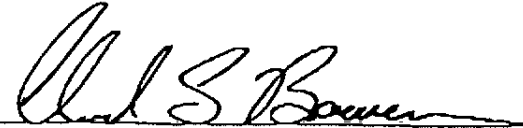
