### ARTICLES OF ORGANIZATION

OF

The undersigned subscriber, PAUL B. KOZEL, a natural person competent to contract, herewith files these Articles of Organization pursuant to Section 608.407 Florida Statutes for such organization.

### ARTICLE ONE. Name.

The name of the organization is K.O., LLC. The business address of the organization is 300 South Pointe Drive, Apartment 3205, Miami Beach, Florida 33139, and such other and further addresses as shall be adopted by the manager from time to time.

# ARTICLE TWO. Nature of Business.

The general business to be transacted by this organization is as follows:

- 1. Any business, as defined in Section 608.402 Florida Statutes.
- 2.
