ARTICLES OF ORGANIZATION OF

KWF ONE, LLC

A FLORIDA LIMITED LIABILITY COMPANY

- 1. Name. The name of the Limited Liability Company is KWF ONE, LLC, a Florida limited liability company (the "Company").
- 2. <u>Duration</u>. The Company shall exist from the date of filing of these Articles of Organization with the Department of State until the earlier of fifty (50) years from the date of filing or the occurrence of any of the events specified in Florida Statutes Section 608.441 unless continued by the unanimous consent of all of the remaining members.
- 3. <u>Purpose.</u> The Company is organized for the purpose of transacting all tawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
