

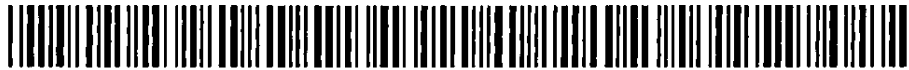

1. The Articles of Organization of CENTRAL FLORIDA REHAB & WELLNESS, PL, a Florida limited liability company, were filed on April 22, 2002, and assigned document number L02000009544.
