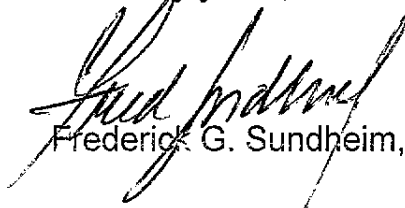

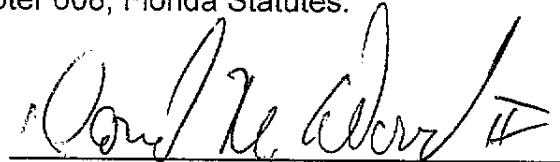

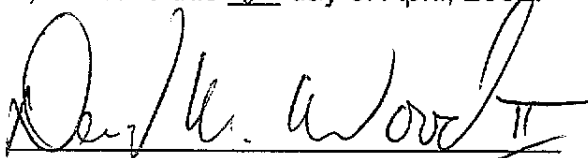
Article VI

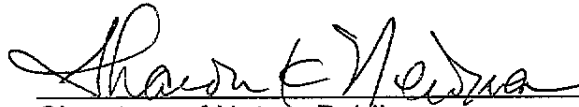
